- Transactions through UPI rose **7.7 per cent to 730 crore** and the total value stood at **more than Rs 12.11 lakh crore in October.**
- **In September, there were 678 crore UPI-led digital transactions worth Rs 11.16 lakh crore.**
- The number of instant interbank fund transfer through **IMPS (Immediate Payment Service) in October stood at 48.25 crore** and the value was at **Rs 4.66 lakh crore.**
- In terms of transactions, **it was higher by 4.3 per cent compared to September**, according to the monthly data from the National Payments Corporation of India (NPCI) released

- **Alembic Pharmaceuticals Ltd** said it has **received final approval from the US health regulator for its generic version of Glycopyrrolate injection** used as a pre-operative medication to **inhibit salivary gland and respiratory secretions**.
- The approval by the **US Food & Drug Administration (USFDA)** is for the **Abbreviated New Drug Application (ANDA)** for **Glycopyrrolate injection**.
- The approval is for strengths **0.2 mg/1 mL and 0.4 mg/2 mL (0.2 mg/mL) single-dose vials and 1 mg/5 mL (0.2 mg/mL) and 4 mg/20 mL (0.2 mg/mL) multiple-dose vials**.
- This is the **first injectable product approval from our general sterile facility (F-3) which was inspected in August 2022**.



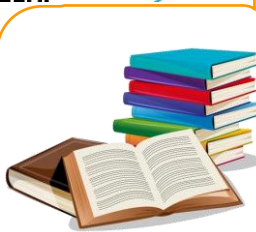

- The gross revenue from goods and services tax (GST) rose 18 per cent year-on-year to Rs 1,51,718 crore in October 2022.



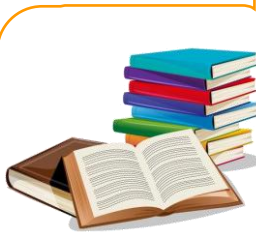

- Earlier in August this year, Adani Power had informed the bourses that it has **agreed to acquire DB Power Ltd (DB Power)**, which owns and operates a running 2x600 MW thermal power plant at district Janjgir Champa in Chhattisgarh.
- The **DB Power has long and medium-term power purchase agreements for 923.5 MW of its capacity, backed by fuel supply agreements with Coal India Ltd,** and has been operating its facilities profitably.



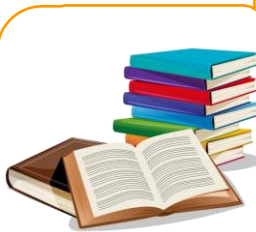

- The order was **issued based on the recommendations of an expert committee**, which conducted a **comprehensive study on the formulation of a common framework for pay/wage structure of PSUs in the state except Kerala State Electricity Board, Kerala State Road Transport Corporation and Kerala Water Authority.**
- However, this **will not be applicable to those employees who have already retired in accordance with the prevailing rules.**
