


The 7th UN Global Road Safety Week

- It focuses on sustainable transport, in particular the need to shift to walking, cycling and using public transport. Road safety is both a prerequisite for and an outcome of this shift.











International Day of Plant Health

- The panel, with a two-year tenure, comes in the backdrop of mental health being identified as an important area requiring attention for insurance coverage.





- Under the partnership, TASK will help HDFC Bank to hire trained students, and it will provide logistical support for placement drives and interviews.













APPOINTMENTS



- The high-powered selection committee headed by Prime Minister Narendra Modi has appointed Karnataka DGP Praveen Sood as Director of the Central Bureau of Investigation (CBI) for a period of two years. He will take charge from Subodh Kumar Jaiswal, who completes his tenure on May 25.
- A 1986-batch IPS officer of the state cadre, Sood was appointed Karnataka DGP in January 2020, superseding Ashit Mohan Prasad.
- Sood was decorated with Chief Minister's Gold Medal for excellence in service in 1996, Police Medal for Meritorious Service in 2002 and President's Police Medal for Distinguished Service in 2011.
- The tenure of the CBI director is limited to a **fixed two-year term**, which can be extended up to a **maximum of five years**.










INTERNATIONAL AFFAIRS

- INS Kavaratti, indigenously designed & built ASW Corvette, arrived at Batam, Indonesia to participate in the 4th edition of India-Indonesia Bilateral exercise Samudra Shakti-23 from 14-19 May 23.
- An Indian Navy Dornier Maritime Patrol aircraft and Chetak helicopter is also participating. The Indonesian Navy will be represented by KRI Sultan Iskandar Muda, CN 235 Maritime Patrol Aircraft and AS565 Panther Helicopter.
- Exercise **Samudra Shakti** is aimed at enhancing interoperability, jointness and mutual cooperation between both the navies.
- The Harbour phase will comprise Cross deck visits, professional Interactions, Subject Matter Expert Exchanges, and sports fixtures.
- During the Sea Phase, weapon firing, Helicopter Operations, Anti-submarine warfare & air defence exercises and boarding operations are planned.
- Samudra Shakti -23 will showcase the high level of interoperability between the two navies and their shared commitment towards peace and stability in the region.

- Defence Minister Rajnath Singh approved the 4th Positive Indigenisation List (PIL) of 928 strategically-important subsystems, spares, and components, which will help the government avoid imports worth ₹715 crore.
- In the list, Mumbai-based Mazagon Dock Shipbuilders Limited (MDL), a leading PSU shipyard, has decided to buy a maximum of over 870 items -- such as Line Replacement Units (LRUs)/Subsystems/Spares and Components, including high-end materials and spares -- from the domestic players to promote 'Atmanirbharta' or self-reliance.
- Similarly, HAL has 25 items, mostly for its HTT-40 trainer aircraft, which will replace the Indian Air Force's retired HPT-32 Deepak and the remaining are for Sukhois-30MKIs and Jaguars.







Explanation

- The previous three Positive Indigenisation Lists, published in December 2021, March 2022, and August 2022 respectively, contained 2,500 items for which the country is no longer dependent on foreign manufacturers or suppliers.
- Of another 1,238 items, 310 too have been indigenised and the remaining will happen within the given timelines.
- Over 450 of the items in the fourth list are different kinds of components of "magazine fire-fighting systems", while 260 are related to gas turbine generators and 147 to shafting. The list also includes several items connected to the HTT-40 trainer aircraft, including main and nose wheel tyres and multi-function displays.





- **A BrahMos supersonic cruise missile** was successfully tested from the Indian Navy's frontline guided missile ship **INS Mormugao**.
- The missile launch displayed the Indian Navy's might at sea.
- Earlier in March, Indian Navy had successfully test-fired in the Arabian Sea the ship-launched version of the BrahMos supersonic missile.
- **BrahMos Aerospace Pvt Ltd**, a joint venture between India and Russia, manufactures supersonic cruise missiles that can potentially be launched from submarines, ships, aeroplanes, or land platforms.
- The BrahMos missile travels at 2.8 Mach, or nearly three times the speed of sound. The BrahMos missiles are also exported by India.
- In January of last year, India signed a **\$375 million** deal with the Philippines to deliver three missile batteries.









- The second meeting of the G20 Culture Working Group Meeting, which begins in **Bhubaneswar**, will focus on achieving sustainability through crafts and heritage.









- Minister of State for Electronics and Information Technology Rajeev Chandrasekhar launched the third Semicon India future design roadshow at IIT Delhi.

- The aim of these shows is to promote semiconductor designers and develop a culture of co-development and joint ownership of intellectual property with active industry participation.











- The Central Board of Indirect Taxes and Customs has rolled out automated scrutiny of GST returns aimed at improving tax compliance and to boost revenue collections.
- The move comes after Union Finance and Corporate Affairs Minister Nirmala Sitharaman directed the board to roll out the non-intrusive compliance verification system for GST returns.
- The module enables officers to scrutinize GST returns of Centre Administered Taxpayers, selected on the basis of data analytics and risk identification by the system. Discrepancies associated with returns risk are displayed to the tax officers.









 The module offers tax officers a workflow to interact with taxpayers via the GSTN Common Portal to communicate discrepancies identified under FORM ASMT-10, receipt of taxpayer's response in FORM ASMT-11 and subsequent action, such as issuing an order of acceptance of reply in FORM ASMT-12 or a show cause notice, or initiating an audit/investigation.









