- The sale of HDFC Credila, the education loan arm of the Housing Development and Finance Corporation (HDFC), comes ahead of the completion of HDFC's merger with HDFC Bank.
- In April, the RBI had asked HDFC to reduce its stake in Credila to under 10 per cent over the next two years.
- The stake will be acquired by Kopvoorn B.V, Moss Investments Ltd, Defati Investments Holding B.V and Infinity Partners. While Kopvoorn B.V. is part of the BPEA EQT group, Moss Investments Ltd, Defati Investments Holding B.V. and Infinity Partners are part of the ChrysCapital group.
- The total revenue of HDFC Credila during the 2022-23 fiscal was Rs 1,352.18 crore and its net worth as on March 31, 2023, was Rs 2,435.09 crore.

- Adhia, a Gujarat cadre IAS officer of the 1981 batch, currently serves as an advisor to the Gujarat Chief Minister Bhupendra Patel.








- A Memorandum of Understanding (MOU) between the Department of Economic Affairs, Ministry of Finance, Government of India and the Department of Finance, Government of Philippines, on Financial Technology (fintech) cooperation was signed in Manila.
- The MOU was signed by **Shambhu S. Kumaran**, Ambassador of India to the Philippines and **Benjamin E Diokno**, Secretary, Department of Finance (DOF).
- The MOU envisages the constitution of a Joint Working Group (JWG) cochaired at the undersecretary level from the Ministries of Finance, and comprising senior representatives from Foreign and IT Ministries, Central Banks, financial sector regulatory institutions and other related agencies as members.
- The JWG would identify concrete measures for partnership in innovative technologies; fintech industry, digital governance; payment linkages; creation of interoperable APIs; financial inclusion and other related areas.

- The Agneyastra-1 exercise included various artillery platforms of the Indian Army, including the newly-inducted Korean K-9 Vajra-T 155mm/52 calibre self-propelled howitzer (SPH), FH-77 Bofors 155mm/39 calibre towed howitzer and mortars.
- Ideaforge switch UAV provided real-time imagery of the exercise area indicating that Indian Army has fully integrated switch UAVs in their battle plans.
- Anti-tank missiles and Carl Gustav rocket launchers (RLs) were also used in the exercise.







- Recently, the IAF bought 36 Rafale fighter jets from Dassault, a French manufacturer of combat aircraft.









