






- The Reserve Bank of India (RBI) directed Karnataka-based Mahalaxmi Cooperative Bank, Dharwad to function only as a nonbanking institution.
- The RBI cancelled the banking licence dated March 23, 1994 granted to the Mahalaxmi Cooperative Bank Dharwad, the banking regulator said. The cancellation of licence is with effect from the close of business on June 27, 2023.
- This makes it obligatory on the part of **Mahalaxmi Cooperative Bank Ltd**., Dharwad, and Karnataka to stop conducting the business of 'banking' within the meaning of section 5(b) of the Act ibid, including acceptance of deposits from non-members with immediate effect.







- Mahalaxmi Cooperative Bank Ltd., Dharwad, Karnataka will ensure to repay unpaid and unclaimed deposits of non-members held by it, whenever demanded, even after being notified as non-banking Institution.
- In April 2023, the central bank cancelled the banking licence of Adoor Co-operative Urban Bank and allowed it to operate only as NBFC.
- The RBI imposed penalties on seven cooperative banks for contravention of/non-adherence with the certain norms issued by the central bank for the same.
- These cooperative banks were —Textile Traders Co-operative Bank Ltd, Ujjain Nagarik Sahakari Bank Maryadit, Panihati Co-operative Bank, The Berhampur Co-operative Urban Bank, Solapur Siddheshwar Sahakari Bank, Uttar Pradesh Co-operative Bank Limited and the Uttarpara Co-operative Bank, the central bank said in statements.





- The central bank had imposed a penalty of ₹28 lakhs on Uttar Pradesh Co-operative Bank Limited.
- A monetary penalty of ₹4.50 lakhs was imposed on Textile Traders Co-operative Bank Ltd. Further, the central bank imposed ₹2.50 lakh penalty each on Panihati Co-operative Bank and The Uttarpara Cooperative Bank.
- Solapur Siddheshwar Sahakari Bank faced a penalty of ₹1.50 lakh. Similarly, ₹1 lakh each penalty was imposed on Ujjain Nagarik Sahakari Bank Maryadit and The Berhampur Co-operative Urban Bank.



Explanation

- A Memorandum of Understanding (MoU) was signed between Ministry of Culture and Canara Bank for disbursal of financial assistance to veteran artists under the "Scheme for Financial Assistance for Veteran Artists".
- Ministry of Culture administers a Scheme namely "Financial Assistance for Veteran Artists" under which financial assistance of Rs. 6000/- per month is provided to artists and scholars above the age of 60 years who have contributed significantly in their specialized fields of performing arts and culture in their active age or are still contributing, but due to old age they are facing difficulty and are in penury condition.
- Currently, under the scheme, disbursal of financial assistance in respect of artists selected before 2017 is made through LIC while for the artists approved post 2017, it is made directly by the Ministry.








- It has been noted that the receipt of documents from the beneficiaries often get delayed resulting in disbursal of amount as lump sum instead of being released on a regular basis. With the signing of the MoU with Canara Bank, in a period of approximately two months post streamlining of the process, disbursal of financial assistance to the veteran artists would commence on monthly basis, also ensuring redressal of long pending grievances of beneficiaries.
- This initiative is reflective of the Culture Ministry's commitment to constantly improve the interface with the artists' community and the services provided to them.











- On the other hand, the life insurance cover will continue till the age of 85 ensuring the family has sufficient financial resources to continue with their lives.







Mehta had taken over as the MD & CEO of HUL in October 2013.








- The Federal Bank announced that the Reserve Bank of India (RBI) has given approval for the appointment of AP Hota as part time chairman of the private sector bank with effect from June 29, 2023, till January 14, 2026.
- **AP Hota** has banking experience of over 27 years in Reserve Bank, mostly in technology and payment systems, from 1982- 2009.
- While at Reserve Bank of India, he served as nominee director to the Board of Vijaya Bank and subsequently Andhra Bank.









- AP Hota was appointed as Independent Director of Federal Bank Limited with effect from January 15, 2018.
- Earlier this month, Federal Bank had elevated its wholesale banking head Harsh Dugar as executive director of the bank with immediate effect. RBI has approved Harsh Dugar's appointment for three years, effective June 23.













- Angela Bassett, Mel Brooks and editor Carol Littleton will receive honorary Oscars at the motion picture academy's annual Governors Awards in November during a ceremony that will also include the presentation of the Jean Hersholt Humanitarian Award to the Sundance Institute's Michelle Satter.
- Bassett, 64, was nominated for a supporting actress Oscar this year for her turn as Queen Ramonda in "Black Panther: Wakanda Forever," becoming the first actor to earn academy recognition for a Marvel movie.
- Brooks, who turns 97, is a comedy legend, one of 18 people to belong to the EGOT club as a winner of Emmy, Grammy, Oscar and Tony awards. Brooks' Oscar win came for writing the original screenplay for 1967's "The Producers." (A later Broadway adaptation of the film earned him three Tonys.) Brooks was nominated twice in 1975 for writing the adapted screenplay for "Young Frankenstein" and for writing the title song for "Blazing Saddles."



- Littleton, 80, earned an Oscar nomination for her editing work on Steven Spielberg's "E.T. the Extra-Terrestrial" and collaborated with Jonathan Demme ("Beloved," "The Manchurian Candidate") and Lawrence Kasdan ("Body Heat," "The Big Chill") on multiple films.
- She has served as governor of the academy's film editors branch, president and vice president of the Motion Picture Editors Guild and on the board of directors of American Cinema Editors.
- Satter has also led the Sundance Institute's international initiatives in Asia, Europe, India, Latin America and the Middle East. She established and manages the vision and content of Sundance Collab, a global digital storytelling community and learning platform.









- **The Honorary Award**, an Oscar statuette, is given "to honor extraordinary distinction in lifetime achievement, exceptional contributions to the state of motion picture arts and sciences, or for outstanding service to the Academy."
- The **Jean Hersholt Humanitarian Award**, also an Oscar statuette, is given "to an individual in the motion picture arts and sciences whose humanitarian efforts have brought credit to the industry."
- The four Oscar statuettes will be given at the academy's 14th Governors Awards on Nov. 18 at the Fairmont Century Plaza in Los Angeles.






- Defence Research and Development Organisation (DRDO) organised an 'Anusandhaan Chintan Shivir' in New Delhi, with the aim to encourage Defence R&D within the industry and academia. Chief of Defence Staff General Anil Chauhan was the Chief Guest at the event.
- A list of 75 technology priority areas were released on the occasion. The list identified by the DRDO is further divided into 403 technological categories, which further spread out to 1,295 current & future technology development tasks.










- After assessment & shortlisting of candidates, IBM will leverage its resources and expertise to facilitate the recruitment, training, and upskilling of exservicemen for those roles.


















- The Union Minister of Ports, Shipping & Waterways and Ayush Shri Sarbananda Sonowal launched 'Sagar Samajik Sahayyog' - the new guidelines of Corporate Social Responsibility (CSR) by the Ministry of Ports, Shipping & Waterways.
- The new guidelines empower ports to undertake CSR activities directly.
- The event was also attended by Union Minister of State for Ports, Shipping & Waterways, Shri Shantanu Thakur & Union Minister of State of Ports, Shipping & Waterways, Shripad Yesso Naik.
- The new CSR guidelines unveiled will impact projects and programmes relating to activities specified in Section 70 of the Major Port Authorities Act, 2021.








- For the purpose of planning and implementing CSR projects, a Corporate Social Responsibility Committee shall be constituted in each major port. The Committee shall be headed by the Dy. Chairperson of the Major Port and shall have 2 other Members.
- Each major port shall prepare a Corporate Social Responsibility Plan for every financial year, and integrate its CSR in Business Plan with the social and environmental concerns related to the business of the entity.
- CSR Budget will be mandatorily created through a Board Resolution as a percentage of net profit.
- A port with an annual net profit of ₹100 crores or less can fix between 3% 5% for CSR expenses.









Explanation

- Similarly, ports with a net profit between ₹100 crores to ₹500 crores annually, can fix its CSR expenses between 2% and 3% of its net profit, subject to a minimum of ₹3 crores.
- For ports, whose annual net profit is above ₹500 crores per year, the CSR expenses can be between 0.5% and 2% of its net profit. 20% of CSR expenses must be earmarked to Sainik Kalyan Board at district level, National Maritime Heritage Complex and National Youth Development Fund.
- 78% of funds should be released for the social & environmental welfare of the community in areas like drinking water, education, vocational training, skill development, electricity through non-conventional & renewable sources, health & family welfare, promotion of livelihood for economically weaker section of society, community centres, hostels etc.
- A sum of 2% total CSR expense has been earmarked for monitoring of the projects under the CSR programmes by the Ports.





- Indian Prime Minister Narendra Modi launched **five Vande Bharat trains** to improve connectivity across six states in the country.
- The semi-high speed trains will run in Madhya Pradesh, Karnataka, Maharashtra, Goa, Bihar and Jharkhand.
- Two of the trains are for Madhya Pradesh, where assembly elections are scheduled later this year.
- The launch was attended by railway minister Ashwini Vaishnaw, Madhya Pradesh chief minister Shivraj Singh Chouhan, governor Mangubhai Patel and Union ministers Narendra Singh Tomar and Jyotiraditya Scindia.
- The Prime Minister flagged off the five semi-high speed trains for Madhya Pradesh, Karnataka, Maharashtra, Goa, Bihar and Jharkhand – two physically and three in virtual mode – from Rani Kamlapati railway station in Bhopal.










- The semi high-speed trains inaugurated are Rani Kamalapati (Bhopal)-Jabalpur Vande Bharat Express, Khajuraho-Bhopal-Indore Vande Bharat Express, Madgaon (Goa)-Mumbai Vande Bharat Express, Dharwad-Bengaluru Vande Bharat Express, and Hatia-Patna Vande Bharat Express.
- The Rani Kamlapati-Jabalpur Vande Bharat Express will connect Mahakaushal region (Jabalpur) to the central region (Bhopal) of Madhya Pradesh.
- The **Khajuraho-Bhopal-Indore Vande Bharat Express** will improve connectivity of Malwa region (Indore) and Bundelkhand region (Khajuraho) to central region (Bhopal), the statement said.
- The Madgaon (Goa)-Mumbai Vande Bharat Express is Goa's first Vande Bharat Express. It will run between Mumbai's Chhatrapati Shivaji Maharaj Terminus and Goa's Madgaon station.











- The Dharwad-Bengaluru Vande Bharat Express will connect important cities in Karnataka – Dharwad, Hubballi and Davangere – with the state capital Bengaluru.
- The Hatia-Patna Vande Bharat Express is the first Vande Bharat train for Jharkhand and Bihar. Enhancing connectivity between Patna and Ranchi, the train will be a boon for tourists, students and businessmen








- **Uttarakhand's Naini Saini airport**, which shut down within a year of beginning operations in 2019, will become functional once again.
- The Director General of Civil Aviation (DGCA), the country's aviation regulator, has granted an aerodrome licence to the Uttarakhand Civil Aviation
 Development Authority (UCADA), which currently manages the airport located strategically close to the India-China border in the state's Pithoragarh district.
- Earlier, the airport was operational in **2019** with flights to Delhi and Dehradun, but operations were stopped within a year.
- Currently, Uttarakhand has two major airports; Jolly Grant Airport in Dehradun and Pantnagar Airport in Udham Singh Nagar.











NAINI SAINI AIRPORT IN BRIEF

- The Naini Saini Airport was constructed in **1991** for administrative purposes. A nine-seater aircraft operated in February 2019, but stopped operating in January 2020 for technical reasons.
- Earlier in February 2023, the airport was transferred to the Indian Air Force.
- With an airstrip of nearly 1,500 meters, the airport can handle small turbo-prop aircraft such as ATR 72-600.







- Caspian Impact Investment Adviser (Caspian Equity) has partnered with the Assam Rural Infrastructure and Agricultural Society (ARIAS) to launch a new investment fund aimed at supporting small and medium-sized enterprises (SMEs) in the agribusiness and allied sectors in Assam, India.
- The collaboration was formalized through a memorandum of understanding (MoU) between the two parties.
- ARIAS will establish and implement the Assam Agribusiness Investment Fund (AAIF), a contributory and determinate investment trust. The fund, with a corpus of Rs 250 crores, will be managed by Caspian Equity. Under the determinate trust structure, the share of beneficiaries is determined during the lifespan of the trust,










- AAIF will operate as a Category II Alternative Investment Fund registered with the Securities and Exchange Board of India (SEBI).
- The World Bank will provide anchor funding for the fund through the Assam Agribusiness and Rural Transformation Project (APART). The primary objective of the fund is to improve agricultural productivity and generate employment opportunities in Assam.













- The Union Cabinet chaired by the Prime Minister, Shri Narendra Modi, has given its approval for ratification of the Headquarters Agreement (HQA) between Government of India (Gol) and Coalition for Disaster Resilient Infrastructure (CDRI) signed on 22nd August, 2022.
- The CDRI was launched by the Hon'ble Prime Minister of India during the United Nations Climate Action Summit on the 23'd September, 2019, at New York. It is a major global initiative launched by the Government of India and is seen as India's attempts to obtain a global leadership role in climate change and disaster resilience matters.
- On the 28 August, 2019, the Cabinet had approved the setting up of CDRI along with its supporting Secretariat in New Delhi and also gave the approval for Government of India financial support of Rs. 480 crore to CDRI over a period of 5 years from 2019-20 to 2023-24.








- Subsequently, on the 29th June, 2022, the Cabinet had approved recognition of CDRI as an International Organization and for signing of Headquarters Agreement (HQA) for granting CDRI exemptions, immunities and privileges as contemplated under Section-3 of the UN (P&I) Act, 1947.
- In pursuance of the Cabinet decision, on 22nd August, 2022 the HQA was signed between the Gol and CDRI.
- CDRI is a global partnership of National Governments, UN agencies and programmes, multilateral development banks and financing mechanisms, the private sector, academic and knowledge institutions that aims to promote the resilience of infrastructure systems to climate and disaster risks, thereby ensuring sustainable development.








- Since its launch, thirty-one (31) Countries, six (06) International Organizations and two (02) private sector organizations have become members of CDRI
- Ratification of the signed Headquarters Agreement between Gol and CDRI will facilitate grant of exemptions, immunities and privileges as contemplated under Section- 3 of the United Nations (Privileges & Immunities) Act, 1947 will provide CDRI an independent and international legal persona so that it can carry out its functions internationally, more efficiently.
