- Voyager Space (Voyager), a global leader in space exploration, is pleased to announce the signing of a Memorandum of Understanding (MoU) with the Indian Space Research Organization (ISRO) Department of Space and the Indian National Space Promotion and Authorization Center (IN-SPACe) to explore opportunities for the utilization of ISRO's Gaganyaan crewed spacecraft to service Starlvvab, a first-of-itskind, continuously crewed, free-flying space station.
- The objective is to jointly study the potential use of ISRO's Gaganyaan spacecraft to provide crewed flights to the Starlab station. - India and Bangladesh have started bilateral trade in rupees.
- It was launched at an event jointly organised by Bangladesh Bank and High Commission of India in Dhaka
- From Bangladesh side trade and transactions with India will be done by its
 Eastern Bank and Sonali Bank Ltd, while from Indian side operations will be
 done by State Bank of India and ICICI Bank.
- Bangladesh is India's biggest trade partner in South Asia and India is the second largest trade partner of Bangladesh in Asia.
- Reserve Bank of India has allowed banks from 18 countries to trade in rupees including Germany, Russia, Singapore, Sri Lanka, the United Kingdom, Myanmar, Oman and others;
- Bangladesh become 19th country to trade with India in rupees.






Explanation

- A **non-resident Indian (NRI)** can now be made a nominee for government saving schemes such as PPF, NSC and post offices savings, said the Finance Ministry in a notification.
- Besides, the government permitted applicants to make changes to their names or surnames.
- These changes are part of list of amendments to the Government Savings Promotion General Rules, as notified by the Finance Ministry.
- The rules cover various schemes provided under Government Savings Promotion Act, 1873 such as Public Provident Fund (PPF), National Saving Certificate (NSC), Sukanya Samriddhi, Senior Citizens Savings Scheme, Mahila Samman Nidhi Post Office Time Deposits, Kisan Vikas Patra, and Post Office Monthly Income Scheme.

Relief for NRIs

- Non-resident Indians shall be eligible to be nominated as nominee subject to the condition that payment to such nominee/s shall be on non-repatriation basis.
- NRIs are not allowed to invest in small saving schemes

Changes to name/surname

To facilitate the account holder to change name or surname

Conversion of account

- According to previous rules, an account opened as a Single Account cannot be subsequently converted into a Joint Account or vice versa.
- Now a proviso has been added to allow for the conversion of a joint account into a single account on account of the death of an account holder.





Explanation

Accounts on the names of minors

- An amendment has also been done related to accounts of minors.
- At present, an adult can open an account on behalf of the minor by submitting proof of age of minor.
- There is a provision for submission of passport size photograph of the account holder.
- The latest rule says that only the recent passport size photograph of the guardian needs to be submitted.






Explanation

Death of Depositor

- Norms related to payments on account of death of a depositor have also been changed.
- If the total amount is up to ₹5 lakh and and there is no nominee and the probate of his will or letters of administration of estate or a succession certificate or legal heir certificate is not produced within six months from the date, then the rightful claimant will be required to fill Form11.
- He will also have to produce death certificate of the account holder, original passbook or deposit receipt, an affidavit, letter of disclaimer, bond of indemnity and identity proof.
- In case of dispute, the amount will be paid to claimant on submission of a succession certificate issued by the Court along with claim form, pass book or deposit receipt or statement of account in original, death certificate of the account holder and identity proof of the legal heir.
- If the amount is more than ₹5 lakh, the payment will be made on the basis of will or letter of succession along with other documents.

- The shippard has been approved by the Indian Navy and the Coast Guard for repairing works.
- The Kattupalli Shipyard near Chennai is a major node in the Southern Defence Corridor which has been undertaking voyage repairs of the US Navy's Military Sealift Command vessels
- Kattupalli shipyard is equipped with a heavy ship-lift, multiple dry berths, and wet berths
 to concurrently enable building of new ships and undertaking repairs and refits
- USNS Salvor was received at Larsen & Toubro's (L&T) Kattupalli Shipyard for voyage repairs.



- The USNS Salvor is a rescue and salvage ship and is used as a platform to support recovery missions.
- This is the third US ship coming to the shipyard for voyage repairs. Earlier, voyage repairs of Marine Sealift Command (MSC) fleet support ships - USNS Charles Drew and USNS Matthew Perry - were undertaken and completed on time
