- It ranked 88 in 2015 (visa free access to 51 countries), 85 in 2016, 87 in 2017, 81 in 2018, 82 in 2019 and 2020, and 81 in 2021.

- Ms. Sairam and Mr. Subramanyam were conferred the title of Chevalier De L'orde Des Arts Et Des Lettres.



- The UK formally signed the Comprehensive and Progressive Agreement for Trans-Pacific Partnership (CPTPP) trade bloc
- UK Business and Trade Secretary Kemi Badenoch, who is also leading the ongoing free trade agreement (FTA) negotiations with India, signed the pact agreed earlier this year during a visit to Auckland and hailed it as a major post-Brexit win for the country.





- The CPTPP is a free trade agreement between 11 countries (12 including the UK). The agreement was signed by all 11 founding member countries on 8 March 2018 but has come into effect at different times in some countries. It came into force on 30 December 2018 for Australia, Canada, Japan, Mexico, New Zealand, and Singapore, later followed by Vietnam, Peru, Malaysia, Chile, and Brunei.
- The UK will be the first non-founding member of the CPTPP, as well as the first European member.





- In a remarkable initiative to revive and preserve the 2000-year-old technique of shipbuilding known as the 'stitched shipbuilding method', the Ministry of Culture and the Indian Navy have entered into a Memorandum of Understanding (MoU).
- The MoU signing ceremony held was graced by the presence of distinguished individuals including Shri Govind Mohan, Secretary, Ministry of Culture; Smt. Uma Nanduri, Joint Secretary, Ministry of Culture; Smt. Priyanka Chandra, Director (AKAM), Ministry of Culture; Rear Admiral Shri K.S. Srinivas; and Commodore Shri Sujeet Bakshi, Commander Shri Sandeep Roy from the Indian Navy.
- The Indian Navy will oversee the implementation and execution of the entire project.





- The stitched ship holds significant cultural value in India, given its historical importance and the preservation of traditional craftsmanship.
- It aims to revive the maritime memory and instill a sense of pride in India's rich maritime heritage among its citizens.

- Chachin grazing festival was celebrated with great fervour by the local graziers of Tawang region near Bumla Pass, Arunachal Pradesh.
- The two-day event held at **Chachin** saw enthusiastic participation from Graziers from all over the Tawang region.
- Chachin and other traditional grazing areas, near Bumla Pass have historically served as the backbone of the local Monpa lifestyle that is largely dependent on nomadic herding – a primitive form of subsistence farming - as means of livelihood.
- The festival featured a medical camp for aiding the local graziers who often live in remote locations without the medical facilities prevalent in urban areas.
- A veterinary camp was also organized to provide similar medical support to the animals –yaks of the local graziers – along with a lecture on animal health that would facilitate the graziers in ensuring better care for their livestock.

- India's top oil firm IOC has signed deals to import liquefied natural gas (LNG)
 from UAE's Abu Dhabi Gas Liquefaction Co Ltd and TotalEnergies of France on
 a long-term basis.
- Indian Oil Corporation (IOC) signed the deals during Prime Minister Narendra Modi's visit to France and the UAE.
- **Head of Agreement (HoA) (was signed)** between Indian Oil Corporation Limited and TotalEnergies Gas and Power Ltd (TotalEnergies) to establish a long-term LNG sale and purchase agreement (SPA).
- IOC signed a deal to import 1.2 million tonnes per annum of LNG from Adnoc-LNG for 14 years starting in 2026.
- The deal with TotalEnergies is for the import of 0.8 million tonnes a year of LNG for 10 years starting in 2026.





- This is the first long-term deal TotalEnergies has signed with an Indian company. Also, this is the first time an Indian company has signed a long-term LNG import deal with Adnoc.
- TotalEnergies is the third largest LNG supplier in the world and would be supplying LNG to IOC from their diversified portfolio across the world.
- ADNOC LNG is the national oil and gas company of the Abu Dhabi government and is the oldest supplier of natural gas from the Middle East.
- India and UAE have a CEPA (Comprehensive Economic Partnership Agreement)
 with UAE Govt which provides for zero customs duty to be applied on LNG
 imports from UAE against an applicable customs duty of 2.5 per cent plus
 surcharge





- LNG is natural gas that has been cooled to minus 162 degress Celcius, changing it from a gas into a liquid that is 1/600th of its original volume. This allows it to be shipped in specially designed LNG vessels.
- India has seven LNG import facilities on the east and west coasts. IOC operates a 5 million tonne a year import terminal at Ennore in Tamil Nadu.
