- Mini device is available at nearly a third of the cost of a regular PoS terminal, and is targetted at small merchants.
- This comes at a time when the competition in the PoS market is fierce, as companies see this as a way of revenue generation.



- State Bank of India (SBI) has introduced UPI interoperability in its Digital Rupee (e rupee), also known as the Central Bank Digital Currency (CBDC).
- This feature is accessible through the 'e rupee by SBI' application and allows SBI CBDC users to scan merchant UPI QR codes for transactions.
- UPI is a popular payment system in India that allows users to make payments by scanning QR codes or entering UPI IDs.
- The interoperability between DigiRupee and UPI will make it easier for customers to use the digital currency for everyday transactions
- The digital rupee, also called as **Central Bank Digital Currency (CBDC)**, was launched by the Reserve Bank of India on a pilot basis on **December 1, 2022**.
- In the Union Budget 2022-23, Finance Minister Nirmala Sitharaman announced about rolling out of the digital currency called Central Bank Digital Currency (CBDC). CBDCs are an electronic form of a sovereign currency.





- As is the case with cash, it will not earn any interest but can be converted to other forms of money, like deposits with banks.
- Also, IDFC First Bank announced the integration of UPI QR codes with its Central Bank
 Digital Currency (CBDC) app aimed to enhance the adoption of digital rupee and boost its
 utilisation.





- The board of InterGlobe Aviation Ltd, which operates India's largest airline IndiGo, approved the creation of financial services arms with an initial investment of Rs 30 crore.
- The company in a filing to the exchanges outlined that the Board of Directors has approved the incorporation of a Private Limited Company with an initial investment of Rs 30 crore.
- The airline's board has approved the investment which will be setup in the Special Economic Zone at Gujarat International Finance Tec-City,
- Furthermore, the airline's board has also approved issuing corporate guarantees worth up to \$996 million to secure the payment obligations of the aforesaid wholly-owned subsidiary.
- IndiGo's announcement comes just a few days after Air India became the first major airline to set up a leasing unit at IFSC Gift City in Gujarat.
- Last year the government exempted aircraft leasing companies from paying corporate and withholding tax on leasing transactions in a bid to promote aircraft leasing from GIFT City.

- Competition Commission of India (CCI) has approved the merger of Tata SIA Airlines
 which operates Vistara with the Tata group's Air India subject to the parties complying with
 certain voluntary commitments.
- The merger also involved Singapore Airlines and Tata Sons Pvt. Ltd. acquiring some shares in the merged entity Air India subject to compliance of voluntary commitments offered by the parties.
- The transaction also involves acquisition of additional shares in the merged entity by Singapore Airlines in a preferential allotment.
- Tata Sons had acquired Air India in January 2022 through its subsidiary Talace Pvt. Ltd.
- The Tata group had announced last November that as part of the merger, SIA will
 invest ₹2,059 crore in Air India. Post the consolidation, SIA will hold 25.1% shareholding in
 Air India. The deal is to be completed by March 2024.
- TSAL is a joint venture between the Tata Group and the Singapore Airlines with the former holding 51% and the latter 49%.

- SpaceX launched a new batch of Starlink internet satellites to low-Earth orbit.
- The company's Falcon 9 rocket with **23 satellites lifted off** from Launch Complex 39A (LC-39A) at NASA's Kennedy Space Center in Florida.
- This was the 10th flight for the rocket's first stage booster supporting mission, which
 previously supported SES-22, ispace's HAKUTO-R Mission 1, Hispasat Amazonas Nexus
 mission, CRS-27, and five Starlink missions.
- Meanwhile, SpaceX's Dragon spacecraft with Crew-6 members aboard is set to splashdown
 off the coast of Jacksonville
- Crew-6 flew to the space station on a SpaceX Falcon 9 rocket from the agency's Kennedy Space Center in Florida.
- The four-member crew including NASA astronauts Stephen Bowen and Woody Hoburg, Rocosmos cosmonaut Andrey Fedyaev, and UAE (United Arab Emirates) astronaut Sultan Alneyadi, are returning home after a nearly six-month stay at the International Space Station.
- The Dragon spacecraft, named Endeavour, undocked from the forward-facing port of the Space Station's Harmony module



- The Archeological Survey of India (ASI) has 3,697 monuments under its ambit.
- The 'Adopt a Heritage 2.0' programme seeks to foster collaboration with corporate stakeholders through which they can contribute to preservation of these monuments for the next generations
- The programme is a revamped version of the earlier scheme launched in 2017 and clearly
 defines the amenities sought for different monuments as per the AMASR Act, 1958.
- It invites corporate stakeholders to enhance amenities at a monuments by utilising their corporate social responsibility (CSR) funds, the culture ministry said.





- An e-permission portal, with URL www.asipermissionportal.gov.in, for obtaining permission for photography, filming and developmental projects on monuments was launched on the occasion.
- The portal will fast-track the process for obtaining various permissions and solve operational and logistical bottlenecks involved







- Chief Minister Pushkar Singh Dhami launched the logo and website of Uttarakhand Global Investors' Summit during a programme organised in Dehradun






