## **Important Days**



- Hindi Diwas is celebrated on September 14 every year to commemorate the adoption of Hindi as the official language of India by the Constituent Assembly of India on this day in 1949.
- Pandit Jawaharlal Nehru, the first prime minister of India, officially declared 14 September as the Hindi Diwas.
- After India gained Independence, a need for an official language was felt to streamline communication between government departments and to reach out to the public.
- The Constituent Assembly then accepted Hindi as the official language of India on September 14, 1949.
- The first Hindi Diwas was celebrated in 1953. Hindi was adopted as one of the official languages under Article 343 of the Indian Constitution.
- While September 14 is celebrated as Hindi Diwas or National Hindi Divas in India, January 10 is celebrated as World Hindi Day.
- World Hindi Day is celebrated on January 10 every year, with an aim to promote the use of the Hindi language worldwide.





- The initiative aims to provide a personalised and hassle-free airport experience to Air India ticket-holders across 16 major Indian airports
- As part of 'Project Abhinandan,' Air India has deployed a team of specially trained service assurance officers (SAOs) who will be stationed at strategic touch points inside airports.

- The Geological Survey of India Training Institute (GSITI) in Hyderabad has inked a 5-year Memorandum of Understanding (MoU) with the Indian Space Research Organisation (ISRO) in Bengaluru as part of the National Natural Resources Management System (NNRMS) program.
- The MoU was formally signed by Dr. Mathew Joseph, Deputy Director General & Head of Mission-V, representing GSITI, and Dr. JV Thomas, Director of the Earth Observation Applications and Disaster Management Support Programme Office (EDPO) at ISRO.
- The signing ceremony took place in the presence of Shantanu Bhatawdekar, Scientific Secretary at ISRO
- The MoU signing was attended by key officials, including Dr. Nisha Rani, Director of the PGRS Division at GSITI, Dr. John Mathew, Associate Director at EDPO, and Dr. Rajeev Jaiswal, Associate Director at EDPO, ISRO.
- Under this collaborative project, the focus will be on enhancing capacity in the areas of mineral resources and disaster management within the framework of the NNRMS program.





- The primary objective is to build a skilled workforce proficient in the application of Digital Image Processing and Geographic Information Systems (GIS) in Mineral Exploration, as well as in Advanced Remote Sensing Techniques for Mineral Exploration and the application of Geo-informatics in Disaster Management.
- The PGRS Division at GSITI, Hyderabad, will host a total of 15 training programs over the next five years, with an estimated 300 participants.
- These participants will represent Central and State Government Departments, Public Sector Undertakings (PSUs), faculty members, and research scholars from academic institutions.
- This collaboration aims to equip individuals with the necessary expertise and knowledge to contribute effectively to the sustainable management of natural resources and disaster response efforts.


#### **Explanation**

- Odisha government signed a MoU with six Public Sector Banks, for providing banking services in all unbanked Gram Panchayats of the state through CSP Plus banking outlets.
- The Finance department signed the MoU with State Bank of India, Punjab National Bank, Union Bank of India, UCO Bank, Bank of India and Bank of Baroda for providing banking services in all unbanked Gram Panchayats of the State.
- Out of 6798 GPs, around 65 percent of GPs (4373 GPs) do not have brick and mortar branches.
   A brick-and-mortar branch is needed in every GP for easy access to banking services and strengthening the Direct Benefit Transfer system in the State
- Odisha is the first State in the entire country to adopt such an exemplary model for providing banking services to all GPs.
- People residing in all Unbanked Gram Panchayats of the State will have easy access to all kinds of banking services, free of cost.

- Senior citizens, differently abled people and pregnant women will get doorstep banking services and avail the Direct Benefit Transfer of the Government in a timely manner.
- The scheme will be implemented in a phased manner to cover all unbanked GPs of the State within the current financial year 2023-24.
- The Odisha Government will provide rent free banking space for 5 years and bear one-time expenses for Fixed Cost & Recurring expenses for a period of three years. A provision of Rs. 500 crores has been made for the scheme



- The partnership aims at enhancing and disseminating collaborative digital public goods like **DiCRA (Data in Climate Resilient Agriculture)**.
- DiCRA provides open access to key geospatial datasets pertinent to climate resilient agriculture.
- DiCRA, which is curated by UNDP and partner organisations to inform public about investments in agriculture, already provides intelligence on climate resilience for 50 million hectares of farmland across the country.

- The private job portals partnering with the Ministry of Labour and Employment will share their vacancies on NCS so that the NCS registered jobseekers can seamlessly apply for such vacancies.
- On behalf of Ministry of Labour and Employment, the MoUs were signed by Shri Amit Nirmal, Deputy Director General (Employment) in the presence of Smt. Arti Ahuja, Secretary Ministry of Labour and Employment and Shri Ramesh Krishnamurthi, Additional Secretary (Labour and Employment).
- The MoUs were signed with TeamLease HRtech (Freshersworld), Monster.com India Pvt Ltd referred as foundit, QUESS CORP Limited, Delivery Track (VSS Tech), KARPAGA Assessment APP MATRIX Services Private Limited (HireMee), QUIKR INDIA Private Limited, TCS iON, and Firstjob.co.in to share their vacancies with NCS portal.
