- Fair trade regulator Competition Commission of India (CCI) approved the merger of IDFC Ltd with IDFC FIRST Bank.
- IDFC FIRST Bank is in the business of providing banking services, while its parent IDFC Ltd (IDFCL) is an RBI-registered non-banking financial company.
- The deal is subject to conditions, including the merger of IDFC Financial Holding into IDFC Ltd in the first step and subsequently, the amalgamation of IDFCL with IDFC FIRST Bank. Further, CCI also approved the cancellation of the existing shares held by IDFC Financial Holding in IDFC FIRST Bank and then the issue of new shares of the bank to IDFCL's shareholders.
- IDFC Financial Holding is a non-operative financial holding company registered with the Reserve Bank of India (RBI).
- In July, IDFC FIRST Bank announced the merger of its parent IDFC Ltd with itself in an all-stock transaction. Also, boards of IDFC FIRST Bank and IDFC have approved the reverse merger and said the composite scheme of amalgamation includes the merger of IDFC and IDFC Financial Holding Company with IDFC First Bank.

- The only unanimous vote was the 76-0 result for Cecilia Tait, a three-time
 Olympian in volleyball and a former congresswoman from Peru. Tait helped
 Peru win a silver medal at the 1988 Seoul Olympics.
- The first Israeli to win an Olympic medal, Yael Arad, also was elected, 71-5.
 Now president of the Israeli Olympic committee, she won silver in judo at the 1992 Barcelona Olympics.

- Businessman Daniel Noboa, 35, will become the youngest president in Ecuador's history
- With more than 97% of votes counted, Mr Noboa, a centrist, had a lead of four percentage points over his left-wing rival, Luisa González.
- Mr Correa, who governed Ecuador from 2007 to 2017
- He belongs to the brand-new National Democratic Action Alliance, an alliance which incorporates parties from both the left and the right political spectrums
- Before entering politics, he established himself as a businessman, founding his own company at the age of 18 — DNA Entertainment Group, an event organising company.
- He also served as the Shipping Director and commercial and logistics director of Noboa Corporation between 2010 and 2018.
- He is a little-known politician with only a short two-year political stint to his name — a member of the National Assembly of Ecuador between 2021 and 2023.



- Reserve Bank of India (RBI) Governor Shaktikanta Das received the Award for being ranked 'A+' in the Global Finance Central Banker Report Cards 2023 in Marakkesh city of Morocco.
- The award recognizes those central bank governors whose strategies outperformed their peers through originality, creativity, and tenacity
- The awards were announced in the month of September and along with RBI Governor Shaktikanta Das, two other central bankers- Thomas J. Jordan of Switzerland and Nguyen Thi Hong of Vietnam earned an 'A+' grade in the Global Finance Central Banker Report Cards 2023.
- The Central Banker Report Card, which have been issued by Global Finance on an annual basis since 1994, assess and assign grades to the central bank leaders in 101 significant regions and nations. It encompasses entities like the European Union, the Eastern Caribbean Central Bank, the Bank of Central African States, and the Central Bank of West African States.

- India has set up an inter-ministerial group to develop a "well thought-out view" on important matters to be discussed during global climate negotiations
- Constituted in August, the inter-ministerial group on climate change comprises
 members from all the ministries and departments concerned, including the Ministry
 of Environment, Forests and Climate Change, Ministry of Power, Ministry of New
 and Renewable Energy, and the Department of Economic Affairs, a source told PTI.
- The group will hold discussions mainly on five issues mitigation, adaptation, loss and damage, climate finance and Article 6 of the Paris Agreement.
- Five sub-groups, one for each topic, have been formed to hold detailed discussions. Each sub-group has five to six officials at the joint secretary level

- The Union Cabinet, chaired by Prime Minister Narendra Modi, approved the project on Green
 Energy Corridor (GEC) Phase-II Inter-State Transmission System (ISTS) for 13 gigawatt
 renewable energy project in Ladakh.
- The project is targeted to be set up by financial 2029-30 with a total estimated cost of Rs 20,773.70 crore and central financial assistance at 40 per cent of the project cost Rs 8,309.48 crore.
- Keeping in view the complex terrain, adverse climatic conditions and defence sensitivities of the Ladakh region, Power Grid Corporation of India Limited (POWERGRID) will be the implementing agency for this project.
- The transmission line for evacuating this to-be-produced power will pass through Himachal Pradesh and Punjab up to Kaithal in Haryana, where it will be integrated with the national grid.





- An interconnection is also planned from this project in Leh to the existing Ladakh grid so as
 to ensure a reliable power supply to Ladakh.
- The project will contribute to achieving the target of 500 GW of installed electricity capacity target from non-fossil fuels by the year 2030.
- Prime Minister Modi, during his Independence Day Speech in 2020, announced the setting up
 of a 7.5 GW solar Park in Ladakh.
- After an extensive field survey, the Ministry of New and Renewable Energy (MNRE) prepared a plan to set up a 13 GW renewable energy generation capacity along with a 12 GWh battery energy storage system in Pang, Ladakh
- India aims to meet its 50 per cent energy needs through renewable sources by 2030. The
 government will spend Rs 3,760 crore as viability gap funding and it will be a 100 per cent
 central grant. The viability gap funding is capped at 40 per cent of the total capital cost of the
 project.





- Viability gap funding is given to support infrastructure projects that are economically justified but fall marginally short of finances. At the COP26 summit in Glasgow in 2021, Prime Minister Narendra Modi had committed to an ambitious five-part "Panchamrit" pledge, including reaching 500 GW of non-fossil electricity capacity, to generate half of all energy requirements from renewables, to reduce emissions by 1 billion tons by 2030.
- India also aims to reduce the emissions intensity of GDP by 45 per cent. Finally, India commits to net-zero emissions by 2070






Centre approves setting up of Khelo India State Excellence Centre at Spithuk in Leh district of Ladakh

Cabinet approves Productivity Linked Bonus (PLB) of Rs 1968.87 Crores for railway employees


- The Union Cabinet chaired by Prime Minister Shri Narendra Modi has approved Productivity Linked Bonus (PLB) equivalent to 78 days' wages for the financial year 2022-23 to all eligible non-gazetted Railway employees namely Track maintainer, Loco Pilots, Train Managers (Guards), Station Masters, Supervisors, Technicians, Technician Helpers, Pointsman, Ministerial Staff and other Group 'C' staff (excluding RPF/RPSF personnel).
- In recognition of this excellent performance by the Railway staff, Union Government has approved payment of PLB of Rs 1968.87 crore to 11,07,346 railway employees.
- The performance of Railways in the year 2022-2023 was very good. Railways loaded a record cargo of 1509 Million Tonnes and carried nearly 6.5 Billion Passengers.





Cabinet approves release of an additional instalment of Dearness Allowance and Dearness Relief due from 01.07.2023

- The Union Cabinet, chaired by the Prime Minister, Shri Narendra Modi has approved to release an additional instalment of Dearness Allowance (DA) to Central Government employees and Dearness Relief (DR) to pensioners w.e.f. 01.07.2023 representing an increase of 4% over the existing rate of 42% of the Basic Pay/Pension, to compensate against price rise. This increase is in accordance with the accepted formula, which is based on the recommendations of the 7th Central Pay Commission.
- The combined impact on the exchequer on account of both Dearness Allowance and Dearness Relief would be Rs.12,857 crore per annum. This will benefit about 48.67 lakh Central Government employees and 67.95 lakh pensioners.





Cabinet approves Minimum Support Prices (MSP) for Rabi Crops for Marketing Season 2024-25

- The Cabinet Committee on Economic Affairs, chaired by the Hon'ble Prime Minister Shri Narendra Modi, has approved the increase in the Minimum Support Prices (MSP) for all mandated Rabi Crops for Marketing Season 2024-25.
- Government has increased the MSP of Rabi Crops for Marketing Season 2024-25, to ensure remunerative prices to the growers for their produce.
- The absolute highest increase in MSP has been approved for lentil (masur) at Rs.425 per quintal followed by rapeseed & mustard at Rs.200 per quintal.
- For wheat and safflower, an increase of Rs.150 per quintal each has been approved. For barley and gram an increase of Rs.115 per quintal and Rs.105 per quintal respectively, has been approved.

- The **Department of Land Resources** signed a pact with the **National Remote Sensing Centre** to monitor the Watershed Development Component (WDC) projects under the Pradhan Mantri Krishi Sinchayee Yojana
- National Remote Sensing Centre (NSRC) will monitor the watershed development projects through high-resolution satellite data and customize software tools for monitoring the projects on the Bhuvan website - an Indian web-based utility, which allows users to explore a set of geographic content prepared by the Indian Space Research Organisation (Isro).
- They will also facilitate online image comparison and visualisation with respect to detailed project reports, customise the Bhuvan web page 'Srishti' for WDC 2.0 projects, and customise the mobile application Drishti for field data collection and data transfer to Bhuvan.
- Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) was launched in 2015-16 to enhance physical access to water on farms, expand cultivable areas under assured irrigation, improve on-farm water use efficiency, and introduce sustainable water conservation practices.





- It is an amalgamation of ongoing schemes like the Accelerated Irrigation Benefit Programme (AIBP) of the Ministry of Water Resources, River Development & Ganga Rejuvenation (MoWR, RD&GR), Integrated Watershed Management Programme (IWMP) of the Department of Land Resources (DoLR) and the On Farm Water Management (OFWM) of Department of Agriculture and Cooperation (DAC).
- The scheme is being implemented by the Ministries of Agriculture, Water Resources and **Rural Development.**
- The Ministry of Rural Development is implementing the Watershed Development Component (WDC), which includes water conservation, and the construction of farm ponds, water harvesting structures, small check dams, and contour bunding, among others.

- The Ministry of Skill Development & Entrepreneurship launched the IndiaSkills 2023-24 programme and felicitated WorldSkills 2022 winners.
- India had secured 11th position in the global competition last year.
- **WorldSkills Competition** is the largest skill competition in the world, held once every two years. It is conducted by WorldSkills International, which has 86 member countries. These competitions provide both a benchmark for high performance and an objective way to assess vocational excellence. The duration of the competition duration is 4 days spanning 16 to 22 hours.
- WorldSkills competition 2022 was conducted from September to November 2022 across Europe, North America, and East Asia comprising over 1,000 competitors from 58 countries in 61 skills.
- The competition was hosted by 15 countries in more than 20 cities. India participated in 50 skills and secured 11th position with 2 Silver Medals, 3 Bronze Medals and 13 Medallions for Excellence at the WSC 2022, its best ranking so far at the WorldSkills Competition.
- Indian Competitors, who represented the country at WorldSkills Competition 2022, were selected via IndiaSkills Competition 2021.





- A total of 165 IndiaSkills National Competition winners were trained for the WorldSkills Competition at designated training venues developed in line with WorldSkills standards under the mentorship of WorldSkills India Experts and trainers.
- More than 200 Industry and Academic Partners like Toyota Kirloskar, Mahindra, Saint Gobain, Larsen & Toubro, Maruti Suzuki, Infosys, IIT-Palakkad, Government Tool Room and Training Centre, National Institute of Fashion Technology, Lincoln Electric, CISCO, BMW, Volkswagen, Berger Paints and others collaborated to train India's competitors, sponsoring approximately Rs. 20 Crore in terms of training infrastructure, subject matter expertise, international training, raw material and tool kits.
- Fifty-six competitors, 50 Experts and 11 Interpreters participated among which 19% were female (11 competitors). Some of the competitors also participated in new-age skills like Robot System Integration, Additive Manufacturing, Industry 4.0, Digital Construction, Mobile Application Development and Renewable Energy.

- India-UK 2 plus 2 Foreign and Defence Dialogue was held in New Delhi.
- The two sides discussed possibilities to boost collaboration, particularly in areas of trade and investment, defence, critical and emerging technologies, civil aviation, health, energy, culture and strengthening people connections.
- The 2 plus 2 dialogue is a mechanism to discuss and review all aspects of the India-UK Comprehensive Strategic Partnership.
- According to the External Affairs Ministry, both countries expressed satisfaction with the regular high-level political exchanges and interactions which have provided guidance and momentum to India-UK multifaceted ties.
- The India-UK relationship was elevated to a Comprehensive Strategic Partnership during the India-UK virtual summit held between Prime Minister Narendra Modi and his then-British counterpart Boris Johnson in May 2021.





- At the summit, the two sides adopted a 10-year roadmap to expand ties in the key areas of trade and economy, defence and security, climate change and people-to-people connections, among others.
- The Indian delegation at the dialogue was co-chaired by Piyush Srivastava, Joint Secretary (Europe West) at the MEA and Vishwesh Negi, Joint Secretary (International Cooperation) at the defence ministry.
- The UK delegation was co-chaired by Ben Mellor, India Director at the Indian Ocean Directorate in the Foreign, Commonwealth and Development Office (FCDO) and Lt General Rob Magowan, Deputy Chief of Defence Staff, Finance and Military Capability at the British **Ministry of Defence**.
