- This resolution called upon Member States to take concrete steps to combat the prevailing culture of impunity.
- The selection of this date is in remembrance of the tragic assassination of two French journalists in Mali on November 2, 2013.












Explanation

- So far, Willey has featured in 70 ODIs and 43 T20Is.







- He has around three decades of professional experience in diverse fields including rolling stock maintenance, project management, system study and optimisation, material management, finance and costing and human resource management.




