






OBITUARY



- Eminent singer, musicologist and writer Leela Omchery, 94, passed away in New Delhi.
- Proficient in Carnatic, Hindustani, Sopanam and folk music, she was honoured her with Padma Shri in 2008
- Sister of yesteryear Malayalam singer Kamukara Purushothaman, Leela was born on May 31, 1929, in Kanyakumari district, now in Tamil Nadu. She had served as professor at Kamuakara School of Music, Dance and Research Studies, Thiruvananthapuram, and later as professor and principal of Trikala Gurukulam in New Delhi.
- She was the president of Dakshina Bharati (South Indian Women's Organisation), and vice-president of Swaralaya, New Delhi.
- She had also worked as associate professor and head of Carnatic Music Section, Faculty of Music and Fine Arts, University of Delhi, in 1964-1994. She won the Kerala Sangeetha Nataka Akademi award in 1990.

- It obtained registration from the International Financial Services Centre Authority (IFSCA) in September 2023 following approval from the Insurance Regulatory and Development Authority of India (IRDAI) in August of the same year.
- IndiaFirst Life would be able to reach a wider audience worldwide thanks to the registration.
- With a dedicated office space reserved in GIFT City, the company is ready to go as soon as the required paperwork is completed.

Explanation

- Former Chief Justice of Delhi High Court, Justice Rajendra Menon, has been appointed again as Chairman of the Armed Forces Tribunal (AFT) for four years.
- Justice Menon will serve as Chairman of the Tribunal till June 6, 2027.
- The former judge was first recommended to the post in 2019 and served for four years.
- In April 2002, Justice Menon was elevated as an additional judge of the Madhya Pradesh High Court in 2002, whereas on May 21, 2003, he was a made permanent judge of that High Court.
- Justice Menon has also served as Welfare Commissioner for the Bhopal Gas Victims Compensation Commission between December 2010 and March 2015.
- Justice Menon was elevated as Chief Justice of the Patna High Court on March 15, 2017 and remained at the post till his transfer to the Delhi High Court.
- He retired as Chief Justice of the Delhi High Court in May 2019, a little under a year after he was appointed to helm the High Court in August 2018.



- India has allocated a "landmark" grant of USD 15 million to Sri Lanka to bolster the longstanding Buddhist connections between the two nations
- The bilateral agreement on the grant was signed at the President's House in Colombo in the presence of President Ranil Wickremesinghe and Finance Minister Nirmala Sitharaman during her three-day visit to the island nation
- The first project to be initiated under the USD 15 million grant is the solar electrification of religious sites across Sri Lanka, with an allocation of USD 10 million
- The Memorandum of Understanding (MOU) for this significant project was jointly finalised by the governments of India and Sri Lanka
- Sitharaman was in the island nation to participate as the Guest of Honour in 'NAAM 200', organised by the Government of Sri Lanka on Thursday, to commemorate the 200th anniversary of the arrival of Indian-origin Tamils to the island nation.













- The Union Minister of Ports, Shipping and Waterways, Shri Sarbananda Sonowal will launch the domestic sailing of the first International Cruise Liner 'COSTA SERENA' in India at Mumbai.
- The 'Dekho Apna Desh', an initiative launched as an appeal by the Prime Minister, Shri Narendra Modi to the middle class to prefer the domestic tourism over the international tourism, drives such cruise initiatives.
- The Ministry of Ports, Shipping and Waterways is very focussed on bringing India on the cruising map of the world.
- At the recently concluded Global Maritime India Summit 2023 organised by the Ministry, discussions revolved around reaching the target of 50 million cruise passengers in India by 2047. This looks achievable as India has a huge potential.
- Costa Cruises is expected to carry approximately 45,000 passengers in its next 2 months voyages. These passengers would have otherwise booked from international destinations. The biggest advantage is an International Cruising experience for Indians in Indian waters

- The event aims to showcase India as 'food basket of the world' and celebrate 2023 as the International Year of Millets




















- The Election Commission of India signed a Memorandum of Understanding, MoU, with the Ministry of Education to bring electoral literacy into classrooms across the country.
- The MoU outlines the development of institutional framework that seeks to embed electoral literacy in schools and colleges.
- It also includes structured curricular, co-curricular and extra-curricular activities that will help prepare new voters for greater electoral participation in democracy.
- Under the MoU, NCERT will include material on electoral literacy in school textbooks and advise state education boards to follow the same. Various activities will be held to promote voter awareness among students, ensuring their registration and participation as voters.
- A robust mechanism will be developed to meet ECI's ambitious target of handing over Voter ID card to every student who attains the age of 18 years.
- The MoU also aims to expand ECI's flagship systematic voter education and electoral participation in schools and colleges. Its objective is to encourage universal and enlightened participation of prospective voters in elections.







- The aim is to bring together best minds, best technologies and best practices while providing business and knowledge sharing opportunities for its participants.



- Held every four years, the World Telecommunication Standardisation Assembly (WTSA) is the governing conference of the ITU Standardisation Sector (ITU-T), one of the three world conferences of the International Telecommunication Union and as such, the United Nations system.
- Meanwhile, Vaishnaw and Houlin Zhao, Secretary General of the International Telecommunication Union (ITU) signed the Host Country Agreement (HCA) for the establishment of an Area Office and Innovation Centre of ITU in New Delhi on 3 March 2022.
- The HCA provides the legal and financial framework for the establishment and operations of the area office.












- The Jharkhand Cabinet approved the 'Abua Awas Yojna' (AAY) a housing scheme for the poor, which will provide eight lakhs pucca houses to the homeless in the state, and has a total budget of Rs 16,320 crore.
- The scheme will be implemented in three phases, with a target of 2 lakh houses in the current financial year; 3.5 lakh houses in FY 2024-25 and 2.5 lakh houses in FY 2025-26.
- xisting Union Government schemes like Pradhan Mantri Awas Yojana-Rural or Ambedkar Awas Yojna have been around for a while.
- As per data from the state government, 16 lakh families have been beneficiaries of PMAY-Rural, and 50,000 families have benefited from Ambedkar Housing Scheme since the formation of Jharkhand in 2000.







- Nonetheless, these schemes have been unable to cover all eligible beneficiaries.
- A three-room and one kitchen house with a total area of 31 sq m will be provided under this scheme. The government has set aside Rs 2 lakh per beneficiary in its budget, to be disbursed in four instalments. In comparison, under PMAY-Rural, a house with only two rooms and one kitchen is constructed, with a provision of Rs 1.2-1.3 lakh per beneficiary.








