




Important Days








- The **Reserve Bank** has imposed monetary penalties on four co-operative banks and a nonbanking financial company (NBFC) for deficiencies in regulatory compliance.
- The co-operative banks are: Shree Lodra Nagarik Sahakari Bank Ltd, Malpur Nagarik Sahakari Bank Ltd, Jolarpet Co-operative Urban Bank Ltd, Limbasi Urban Co-operative Bank and the NBFC is Early Salary Services Private Ltd.
- The Reserve Bank imposed a monetary penalty of ₹4.00 lakh on Shree Lodra Nagarik Sahakari Bank Limited, Lodra, Dist. Gandhinagar, Gujarat for non-compliance with the directions issued by RBI on 'Loans and advances to directors, relatives and firms/concerns in which they are interested' and 'Placement of Deposits with Other Banks by Primary (Urban) Co-operative Banks (UCBs)'.










- the Shree Lodra Nagarik Sahakari Bank had (i) sanctioned a loan to a relative of one of its directors; (ii) sanctioned loans wherein relatives of its directors stood as guarantors; (iii) breached the prudential inter-bank gross exposure limit; and (iv) breached the prudential interbank counterparty exposure limit.
- The RBI imposed a monetary penalty of ₹3.50 lakh on Malpur Nagarik Sahakari Bank Limited, Malpur, Dist. Aravalli, Gujarat for non-compliance with the directions issued by RBI on 'Placement of Deposits with Other Banks by Primary (Urban) Co-operative Banks (UCBs)'.
- The Reserve Bank imposed a monetary penalty of ₹50,000 on the Jolarpet Co-operative Urban Bank Limited, Dist. Vellore, Tamil Nadu for non-compliance with the directions issued by RBI on 'Board of Directors - UCBs' read with the directions issued by RBI on 'Loans and advances to directors, their relatives, and firms/concerns in which they are interested'. The bank had extended loans to directors and their relatives











- The Reserve Bank imposed a monetary penalty of ₹25,000 on the Limbasi Urban Co-operative Bank Ltd., Limbasi, Dist. Kheda, Gujarat for non-compliance with the directions issued by RBI on 'Loans and advances to directors, relatives and firms/concerns in which they are Interested' read with the directions issued by RBI on 'Loans and Advances to Directors etc. - Directors as surety/guarantors – Clarification'.
- The Reserve Bank imposed a monetary penalty of ₹3.20 lakh on Early Salary Services Private Limited, Pune for non-compliance with certain provisions of the "Non-Banking Financial Company – Non-Systemically Important Non-Deposit taking Company (Reserve Bank) Directions, 2016"







- In a significant move towards green energy expansion, the Government of India, the Government of Himachal Pradesh, and the World Bank have signed a USD 200 million project aimed at advancing power sector reforms in Himachal Pradesh
- The project will focus on increasing the share of renewable energy (RE) in the state's electricity generation, aligning with Himachal Pradesh's goal to add 10,000 megawatts of additional RE capacity.
- Himachal Pradesh is on a mission to become a 'Green State' by meeting all its energy needs through renewable and green energy sources by 2030. Currently, more than 80 per cent of the state's energy demands are met through hydropower.
- The Himachal Pradesh Power Sector Development Program, backed by the World Bank, will aid the state in optimizing its existing RE resources, particularly hydropower, while diversifying its RE sources










- This includes the addition of 150 megawatts of solar capacity, expected to reduce greenhouse gas emissions by over 190,000 metric tons annually.
- The Program aims to improve environmental, social, financial management, corporate governance, and procurement capacities in Himachal Pradesh's power sector. It will also create job opportunities in specialized technical and managerial fields, with a particular focus on women.
- The USD 200 million loan from the International Bank for Reconstruction and Development (IBRD) has a final maturity of 14.5 years, including a grace period of 4.5 years.
- The program promises a greener and more sustainable energy future for Himachal Pradesh and contributes to India's broader renewable energy goals










- The Competition Commission of India (CCI) has approved the acquisition of AXA's 49 per cent shareholding in Bharti AXA Life Insurance Company Ltd (Bharti AXA Life) by Bharti Life Ventures Private Ltd (BLVPL).
- The acquisition of 49 per cent shareholding from AXA India Holdings would lead to Bharti Group through BLVPL gaining 100 per cent shareholding and therefore sole control in Bharti AXA Life.
- The CCI has also given its stamp of approval to another transaction involving the acquisition of 48.54% shareholding of Bharti Management Services Ltd (BMSL) by Bharti Enterprises Ltd (BEL) from Societe Be Societe Beaujon, a subsidiary of AXA.
- This would take Bharti Group's total shareholding in BMSL to 100 per cent and acquisition of BMSL's sole control
- BLVPL is a private company incorporated in India. It is a holding company and has its sole investment in Bharti AXA Life.

- BEL is a public unlisted company incorporated in India. It is involved in the provision of management consultancy services.
- Bharti AXA Life Insurance is a public unlisted company incorporated in India. It is involved in the business of providing life insurance policies.
- The Competition Commission of India (CCI) has approved the proposed acquisition of 20.51 per cent equity stake in Indo Rama Synthetics (India) Limited (IRSL) by Aloke Lohia, a promoter of IRSL, from Brookgrange Investment Limited.
- The Competition watchdog has also approved the transfer of 20.51 per cent equity shares of IRSL to Urmila Lohia, a promoter of IRSL, by Aloke Lohia. The transfer would be done by way of gift.






- ICAI has been active in enforcing sustainability guidelines with the SDGs Agenda at its core.

- ICAI also issued 16 audit standards on social audits across 16 thematic focus areas, making India the first country in the world to have social impact assessment standards










- The Indian Institute of Technology Kanpur (IITK) established a Center of Excellence (CoE) named ATMAN (Advanced Technologies for Monitoring Air-quality iNdicators).
- The CoE is a step towards the Atma Nirbhar Bharat initiative, focusing on building indigenous low-cost sensor manufacturing and Artificial Intelligence (AI)/Machine Learning (ML) capabilities to enhance air quality across urban and rural areas of the country.
- It aims to translate sustainable technologies and business models into practical products and services accessible to millions globally.
- It also aims to address critical air quality challenges with cutting-edge technology
- The ambient air quality monitoring of rural areas using indigenous technology AMRIT is a flagship project that will deploy a sensor ambient air quality monitor (SAAQM) network with 1,400 nodes across rural areas in Bihar and UP.











Explanation

- This initiative is the first of its kind to monitor air quality comprehensively in these regions, where data has been limited to cities and towns. The team will work with the authorities of Bihar and UP on AMRIT to enhance air quality action in these states
- The Dynamic Hyper-local Source Apportionment (DHSA) is a cost-effective approach to source apportionment that is being pioneered in Lucknow and Kanpur in UP and will enable authorities to make decisions in their air quality action planning.














- India successfully test-fired its surface-to-surface short-range ballistic missile (SRBM)
 'Pralay' from the Abdul Kalam Island off the Odisha coast
- The missile has been developed by the Defence Research and Development Organisation (DRDO) in view of the country's defence requirements along its borders with neighbouring China and Pakistan
- The missile, launched around 9.50 am, met all its mission objectives, the official said, adding that a battery of tracking instruments monitored its trajectory along the coastline.
- 'Pralay' is a 350-500 km short-range, surface-to-surface missile with a payload capacity of 500-1,000 kg. The solid-fuel, battlefield missile is based on the Prithvi Defence Vehicle.







- Krishi 24/7 will aid DA&FW to identify relevant news, generate timely alerts, and take
 prompt action to protect farmers' interests and promote sustainable agricultural growth

- The introduction of Krishi 24/7 addresses the need for an efficient mechanism to identify and manage agricultural news articles of interest to aid timely decision-making.
- The tool scans news articles in multiple languages and translates them into English.
- It extracts essential information from news articles, such as headline, crop name, event type, date, location, severity, summary, and source link, ensuring that the ministry receives timely updates on relevant events published on the web.











- Punjab cabinet led by Chief Minister Bhagwant Mann approved the One Time Settlement scheme that will set the pre-GST arrears of the traders

- The Cabinet also gave its nod to start Mukhyemantri Tirath Yatra scheme and also to double the Ex-Gratia grant of disabled soldiers.










- The HELINA missile was tested by launching it from the newly-acquired Light Combat Helicopter (LCH)
- The HELINA missile was tested at a higher altitude and range.
- Earlier a week ago, the Indian Army had successfully carried out the inaugural firing of 70mm rocket and 20mm turret guns of light combat helicopter (LCH) Prachand

















Explanation








The Odisha government has recently signed Memorandums of Understanding (MoUs) with three entities to facilitate the development of an ecosystem for the manufacturing of:

- The Odisha government has signed MoUs with three entities to build an ecosystem for the manufacturing of semiconductors
- The government inked the three memoranda of understanding with India Electronic and Semiconductor Association (IESA), global semiconductor giant Synopsys and Electronics and Computer Software Export Promotion Council (ESC).

According to the agreement with IESA, the association will facilitate the Odisha government in developing capacity-building programmes and promoting the semiconductor ecosystem through events and conceptualisation of knowledge materials

 The MoU with Synopsys will involve collaboration in areas such as the O-Chip programme, talent transformation, workforce development, readiness assessment of the state in semiconductors and the very large-scale integration (VLSI) domains, and internship and placement assistance to students of Odisha's engineering institutions





Explanation

- The third MoU with ESC will promote electronics and IT/ITeS exports from the country.
- The government successfully hosted Odisha4Silicon-2023, a pioneering initiative to build a robust semiconductor ecosystem in the region.
- The event also witnessed the launching of the pan-India Design Challenge under O-Chip organised by Electropreneur Park, Bhubaneswar.
- In addition to the MoUs, there are other initiatives, like the launching of the IESA Odisha Chapter, and the Campus Connect Programme which aims at fostering innovation, skill development, and industry-academia collaborations in the state
- The state electronics and IT minister said Odisha has notified its 'Semiconductor Manufacturing and Fabless Policy 2023', which is offering the most competitive and comprehensive bouquet of incentives to investors.
- The state has also launched the Odisha Semiconductor Fab and Fabless Innovation and Acceleration Programme (O-Chip) to catalyze the development of an ecosystem in the state


