Important Days



- World Radiography Day is observed, November 8.
- On November 8, 1895, German physicist Wilhelm Conrad Roentgen made a groundbreaking discovery. The precursor to this event, known as the European Day of Radiology, took place on February 10, 2011, to commemorate the anniversary of Wilhelm Rontgen's passing on February 10, 1923. This initiative was organised by the European Society of Radiology (ESR).
- World Radiography Day was established as an annual event on November 8, coinciding with the anniversary of Roentgen's discovery of X-rays. This new observance replaced the European Day of Radiology, which had previously been held on February 10.
- The theme chosen for World Radiography Day 2023 is "Celebrating Patient Safety."

- Dhruba Narayan Ghosh, one of the doyens of Indian banking, passed away
- Ghosh was the chairman of SBI from 1985 to 1989 and has been credited for many financial reforms in the country.
- He also served as the chairman of Peerless General Finance and Investments for over 10 years from 1996 to 2006 and steered the company through turbulence.
- An authority in banking and financial history, D. N. Ghosh was a bureaucrat, banker, professor, and corporate leader.
- It was during his time at the State Bank of India, that the computerisation drive of branches began

- Quacquarelli Symonds released QS Asia University Rankings 2024.
- Two Indian institutes- IIT Bombay and IIT Delhi have been ranked in the top 50 list.
- IIT Bombay has secured the top position in India and 40th position in overall Asia.
- Similarly, IIT Delhi stood second among Indian institutes and secured 46th rank overall.
- Peking University of China topped the Asia ranking list by securing Rank 1 followed by the University of Hong Kong in the second position and the National University of Singapore in the third place.
- Nanyang Technological University, Singapore and Tsinghua University, China have secured 4th spot.
- Zhejiang University of China secured the 6th position, Fudan University of China in 7th place, Yonsei University of South Korea in 8th spot.
- Korea University stood on 9th place and the Chinese University of Hong Kong secured the 10th position.
- A total of 856 universities from Asia are included in this year's QS Asia University Rankings





- This year, QS Asia University Rankings can also be viewed in sub-regions which include Central Asia, Eastern Asia, South Eastern Asia, and Southern Asia.
- The methodology used to create the ranking is similar to that used for the QS World University Rankings, but with some additional indicators and adapted weightings, read the website.
- The 11 indicators used to compile the QS Asia University Rankings encompass- Academic reputation, Employer reputation, Faculty/ student ratio, International research network, Citations per paper and papers per faculty, Staff with a PhD, Proportion of international faculty, and proportion of international students and Proportion of inbound exchange students and proportion of outbound exchange students

- A recent global survey has ranked Japan lowest for employees' well-being while keeping Turkey at the top and India just behind it, in the second spot.
- The survey was conducted by McKinsey Health Institute, and it assessed employees' physical, mental, social and spiritual health before arriving at the conclusions.
- Japan scored a mere 25 per cent in the poll. Turkey scored highest at 78 per cent, followed by India at 76 per cent and China at 75 per cent, way higher than the global average of 57 per cent.
- The poll results were based on inputs received from 30,000 participants from nearly 30 countries.





- The MoI was signed during a meeting of Shri Bhagwant Khuba, Union Minister of State for Chemicals and Fertilizers with Mr. Ernst Kuipers Minister of Health, Welfare and Sports of the Kingdom of Netherlands.
- An Indian delegation led by Shri Khuba is in Netherlands to participate in the second World Local Production Forum (WLPF) meeting being held in The Hague from 6 to 8 November 2023. The World Local Production Platform is a platform created at the initiative of WHO with the aim of increasing access to medicines and other health technologies.

- Chile has joined the International Solar Alliance (ISA) as its 95th member, a move that strengthens the global partnership aimed at promoting solar energy.
- The formalities were completed when Chile's Ambassador to India, Juan Angulo, presented the Instrument of Ratification to Abhishek Singh, Joint Secretary (Economic Diplomacy) in New Delhi
- The ISA is an alliance co-founded by India and France, focusing on the large-scale deployment of solar energy as a sustainable intervention to counter climate change.
- It emphasizes energy access, security, and transition through collaborative efforts among its member nations
- The alliance is particularly concerned with enabling countries, especially those identified as Least Developed Countries (LDCs) and Small Island Developing States (SIDS), to pursue lowcarbon growth paths.





- The ISA's ambitious goal is to facilitate \$1 trillion in investments for solar energy by 2030
 while working on reducing the costs associated with technology and financing. It aims to
 leverage solar energy in various sectors, from agriculture to transport, thereby enhancing the
 overall energy matrix of its member states.
- The ISA's commitment comes against the backdrop of a stark reality highlighted by the alliance: around six billion people, accounting for 80 percent of the global population, live in regions reliant on imported fossil fuels.
- The ISA envisions renewable energy sources potentially supplying 65 percent of the world's electricity by 2030 and decarbonizing 90 percent of the power sector by 2050



- The Corporate Affairs Ministry (MCA) extended the term of the 16-member Committee on Digital Competition Law (CDCL) up to December 31, 2023.
- The extended term of this panel, which was tasked to submit a draft Bill of proposed digital competition law, had expired on October 31.
- The CDCL, chaired by **MCA Secretary Manoj Govil**, was established on February 6 and given three months to finalize its report and draft the proposed law.
- However, the committee has faced delays and its tenure has been extended multiple times since May 6.
- The CDCL's responsibilities include examining the need for a separate legislation for regulating digital markets and preparing a draft Digital Competition Act (DCA).
- It will also assess whether existing provisions in the Competition Act are sufficient to address challenges arising from the digital economy.
- If the panel recommends a separate digital competition law, it will submit a draft Bill for government consideration


- The Indian Air Force recently conducted the 'Poorvi Akash' mega aerial exercise to test its major weapon systems.
- The exercise featured the S-400 air defense missiles, indigenous fighter aircraft Tejas, and the LCH Prachand.
- The Indian Air Force has acquired three squadrons of S-400 air defense missile systems from Russia, naming them Sudarshan after Lord Krishna's Sudarshan chakra weapon.
- This exercise involved the S-400 missiles, fighter jets like Su-30, Rafales, and Tejas, along with ground troops.
- The Eastern Air Command (EAC) carried out its annual Command-level exercise 'Poorvi
 Akash' from October 30 to November 4.
- This exercise showcased the operational readiness of the Indian Air Force, specifically the Eastern Air Command, which manages air operations over a vast area spanning 12 states, including the seven states in the North-East.


- 'Exercise Poorvi Akash' focused on demonstrating air power's defensive and offensive capabilities in response to various perceived threats, conducted both during the day and night. It aimed to enhance the coordination between the Indian Army and the Indian Air Force.
- The exercise involved joint operations with the Eastern Command (EC) of the Indian Army in the challenging terrain of the Eastern Sector and activated the entire Eastern Sector. Special Forces from both the Indian Air Force (Garuds) and the Indian Army participated in special missions, along with the deployment of air defense assets to simulate realistic battle scenarios.
- The exercise included a wide range of operations, maintenance, and administrative activities to assess operational readiness and provide realistic training.
- The indigenous Light Combat Helicopter 'Prachand' also landed at a high elevation Advance Landing Ground on one of its first such deployment, conducting joint training with ground forces and other combat platforms and systems. Additionally, the indigenously developed Light Combat Aircraft 'Tejas' and the heavy-lift Chinook Helicopters were deployed in various missions as part of the exercise
