- Record-breaking Australian women's captain Meg Lanning has announced her retirement from international cricket after winning seven World Cup titles during a 241-match career.
- The 31-year-old top-order batter, who led Australia to four Twenty20 World Cup titles, one 50over World Cup triumph and a Commonwealth Games gold
- Her exploits as a batter and captain earned her the nickname "Megastar"
- She amassed 8,352 runs in international cricket after making her debut in 2010. That total included 17 centuries and 38 half-centuries.
- Lanning was Australia's skipper for 100 T20Is, 78 ODIs and four Tests. In these matches, she managed to win 76 T20Is, 69 ODI, and one Test as well.
- She is also the highest run scorer for the Aussie women's side in T20Is with 3,405 runs in 132 games at a strike rate of 116 and an average of 36. In ODIs, she has scored 4,602 runs in 103 ODIs at a staggering average of 53 with 15 hundreds and 21 fifties - the third most runs for Australia behind Belinda Clark and Karen Rolton.





- Lanning's first ICC title came at the T20 World Cup in Sri Lanka in 2012 and she followed that up the following year by claiming the 50-over World Cup in India.
- Lanning was named ICC Women's T20I Cricketer of the Year in 2014 and the following year was adjudged the ICC Women's ODI Cricketer of the Year.
- Lanning's last international match was when she fittingly led her country to the T20 World Cup title in South Africa earlier this year.



- ICICI Bank on June 26 announced that it will be considering a proposal for the delisting of ICICI Securities, a subsidiary of the bank
- The decision to delist comes five years after the broking firm made its debut on the bourses.
- In April 2018, the Rs 4,000 crore-IPO of ICICI Securities had received poor response.
- The IPO was subscribed 78 percent overall, with retail investors bidding only 89 percent of the allotted quota.





- **S4S Technologies**, an Indian full-stack food-processing, solar-tech platform, is among the five winners of what's called the "Eco Oscars"—the Earthshot Prize 2023, which was founded by Britain's Prince William.
- Acción Andina, GRST, WildAid Marine Program, S4S Technologies, and Boomitra are named 2023 Winners and will each receive a catalytic £1 million prize to support efforts to scale their innovative climate and environmental solutions.
- The winners were whittled down from a shortlist of 15 finalists, each solving one of the five problems identified by the prize: "Protect and Restore Nature; Clean our Air; Revive our Oceans; Build a Waste-Free World and Fix our Climate."
- The five Winners were selected by Prince William and the Earthshot Prize Council, chaired by the architect of the Paris Agreement, Christiana Figueres. Other council members included Sir David Attenborough, Jack Ma and Indra Nooyi, among others.

- S4S Technologies was selected for its efforts to "build a waste-free world". The Maharashtrabased combats food waste, rural poverty and gender inequality by helping smallholder female farmers preserve and market surplus produce.
- Founded in 2013 by six university friends—Nidhi Pant, Vaibhav Tidke, Swapnil Kokte, Ganesh Bhere, Shital Somani, Tushar Gaware and Ashwin Pawade—S4S Technologies provides rural communities with cheaper solar-powered conduction dryers and food processing equipment to prepare their crops on-site, rather than using cold storage or other more expensive methods of conventional industrial food preservation.
- The Harsh Mariwala's Marico Innovation Foundation-incubated organisation, which also provides market linkages, claims to have helped about 300,000 women smallholder farmers record 10-15% increases in profits, while 2,000 female entrepreneurs have seen income double or triple.










- The Rangiya and Mariani Railway Stations of Northeast Frontier Railway in Assam have been awarded 'Eat Right Station' certification by FSSAI (Food Safety and Standards Authority of India) in recognition of providing high-quality, nutritious food to passengers.
- This certification is awarded by FSSAI to railway stations that set benchmarks for providing safe and wholesome food to passengers.
- This certification has been awarded for the period from September 25th, 2023, to September 24th, 2025 for Rangiya Railway Station and from October 19th, 2023, to October 18th, 2025 for Mariani Railway Station. Further, in its endeavour to ensure safe and hygienic food for passengers, Northeast Frontier Railway has planned to take up more stations in the future to qualify as 'Eat Right Station' by FSSAI for which necessary efforts are being carried out.
- Previously, Guwahati, Harishchandrapur and Lumding Railway Stations of N. F. Railway have been awarded 'Eat Right Station' certification by FSSAI.





- It is to be mentioned here that the 'Eat Right Station' certification is granted by FSSAI to
 railway stations adhering to standard food storage and hygiene practises. The station is
 awarded a certificate upon the conclusion of an FSSAI-empanelled third-party audit agency.
