


Explanation





- Quota Allocation: A total of 1,75,025 pilgrims from India are finalized for Haj 2024. Out of these, 1,40,020 seats are reserved for the Haj Committee of India, benefiting first-time pilgrims, while 35,005 pilgrims can proceed through Haj Group Operators.







 These highway projects are set to create employment opportunities, driving socio-economic growth within the state.


Tourism and Infrastructure:





Black Nunia Rice - 'Prince of Rice':


 The GI tag for Black Nunia rice, or the 'Prince of Rice', from Jalpaiguri district, contributes to the state's agricultural prestige.
