
Explanation



- His earlier best was 2:16:58, which he had clocked while finishing 11th in the Mumbai Marathon last year.










- China's Huang Yongzheng took the silver with a time of 2:15:24 while Kyrgyzstan's Tiapkin Ilya came third in 2:18:18.
- In the women's marathon race in Hong Kong, Ashvini Madan Jadhav finished eighth with a time of 2:56:42 while Jyoti Gawate ended at 11th in 3:06:20.










- Indian Air Force (IAF) conducted Exercise Desert

- While the French participation included the Rafale fighter aircraft and a Multi Role Tanker Transport, the UAE Air Force fielded the F-16.
- These aircraft operated from the Al Dhafra air base in the UAE.
- The IAF contingent comprised of Su-30 MKI, MiG-29, Jaguar, AWACS, C-130-J and Air to Air Refueller aircraft.







- The exercise in Indian FIR was conducted over the Arabian Sea, with IAF aircraft operating from bases within India.
- The main focus of Exercise Desert Knight was on enhancing synergy and interoperability between the three Air Forces.
- The interactions during the exercise facilitated the exchange of operational knowledge, experiences and best practices amongst the participants.









- Over the next three years, the organizations will cocreate and implement scalable youth-driven solutions to address the challenges faced by cities.








- **REC** will be providing line of credit to the tune of Rs 15,000 crore each to eight central public undertakings identified for the implementation of rooftop solar, among other private developers and vendors, amounting to a total credit of Rs 120,000 crore.





REC has also acted as the nodal agency for various other nationwide schemes under the power ministry including rural electrification under the Deen Dayal Upadhyaya Gram Jyoti Yojana (DDUGJY) and the Sahaj Bijli Har Ghar Yojana (SAUBHAGYA) scheme.








About REC:

- REC, a 'maharatna' Central Public Sector Enterprise under the ministry of power, recorded a 13.5% increase in its consolidated net profit for quarter under review at Rs 3,308.42crore from Rs 2,915.33 crore in the same period last year.
- The company's loan sanctions also soared by 177% to Rs 1,32,049 crore, compared to Rs 47,712 crore in Q3 FY23. Of this, the renewable sector contributed 57%.
- REC disbursed Rs 46,358 crore against Rs 29,639 crore in the corresponding quarter last year.
- Its annualised earnings per share (EPS) also accelerated to Rs 50.65 per share as of December 31, 2023 from Rs 40.79 per share in the previous year.

The Cabinet chaired by the Prime Minister Shri Narendra Modi approved the scheme for promotion of Coal/Lignite Gasification Projects of Government PSUs and Private Sector with an outlay of Rs.8,500 crore towards incentive for coal gasification projects under three categories.







The cabinet has approved the scheme as follows:

- Total outlay of Rs.8,500 crore will be provided as financial assistance for coal gasification projects under three categories.
- In category I, Rs.4,050 crore provisioned for Government PSUs in which upto 3 projects will be supported by providing lump-sum grant of Rs.1,350 crore or 15% of capex, whichever is lower.
- In category II, Rs.3,850 crore provisioned for private sector as well as Government PSUs in which lumpsum grant of Rs.1,000 crore or 15% of capex, whichever is lower provided for each project. At least one project will be bid out on tariff-based bidding process and its criteria will be designed in consultation with NITI Aayog.







The cabinet has approved the scheme as follows:

- In category III, Rs.600 crore provisioned for demonstration Projects (indigenous technology) and/or small-scale product-based Gasification Plants under which lump-sum grant of Rs.100 crore or 15% of capex, whichever is lower, will be given to the selected entity who will have a minimum Capex of Rs. 100 Crore and minimum production of 1500 Nm3/hr Syn gas.
- The selection of entities under category II and III shall be carried out through a competitive and transparent bidding process.









The cabinet has approved the scheme as follows:

- The grant will be paid to the selected entity in two equal instalments.
- EGoS chaired by Secretary Coal shall be fully empowered to make any changes required in the modalities of the scheme subject to the condition that overall financial outlay remain within Rs.8,500 crore.
