Mandates and Objectives:

- **Mandates:** Businesses pay GST on inputs and collect GST on outputs. When GST rates are cut, they collect less tax while input tax remains high, causing excess Input Tax Credit (ITC) which gets blocked.
- **Objectives:** To explain how GST rate cuts, despite benefiting consumers, result in financial stress for businesses due to blocked ITC, slow refunds, increased borrowing, and ultimately, interest on credit.



Important Terms Explained:

- **Goods and Services Tax (GST):** A unified indirect tax system in India where tax is levied on both goods and services at multiple points – collected from the consumer but paid by businesses.
- **Input Tax Credit (ITC):** The credit businesses can claim for the GST paid on purchases of goods or services used in their operations, which can be used to offset GST liability on sales.
- **Interest on Credit:** The additional cost businesses incur when they borrow funds (due to blocked refunds or excess ITC) and pay interest on these loans, reducing overall profitability.

- **Blocked Working Capital:** Capital tied up in pending ITC refunds, which cannot be used for operational needs, leading to liquidity challenges and credit dependency.
- **GST Refund Delay:** A systemic issue where excess ITC cannot be quickly refunded by the government, forcing businesses to rely on credit to cover daily expenses.
