
## Mandates and Objectives:

- **Mandates:** The Reserve Bank of India (RBI) has allowed Scheduled Commercial Banks (SCBs) and Tier 3 & 4 Urban Cooperative Banks (UCBs) to provide working capital loans to manufacturers and industrial units using gold or silver as raw materials under the RBI (Lending Against Gold and Silver Collateral) (1st Amendment) Directions, 2025.
- **Objectives:** To enhance credit flow to manufacturing sectors, expand financial flexibility for borrowers and lenders, and extend the benefit previously available only to jewellers to a wider range of industrial and manufacturing entities.



## Important Terms Explained:

- **Working Capital Loan:** A short-term loan used by businesses to finance day-to-day operations. Now manufacturers using gold/silver as inputs can access such loans.
- **RBI Lending Against Gold and Silver Collateral Directions, 2025:** Amended norms allowing banks to lend to manufacturing units using precious metals as raw material, not for speculative or investment purposes.

- **Interest Rate on Advances (Amendment Directions), 2025:** These rules allow earlier revisions of non-credit risk components of loan spreads and offer an option to switch to fixed interest rates at reset points, providing borrowers flexibility.
- **Perpetual Debt Instruments (PDI):** Long-term, non-repayable instruments that qualify as Tier 1 capital under Basel norms. RBI has now expanded the issuance limit for such instruments to boost banks' capital-raising capabilities.
